December 17, 2012 | The U.S. Congress launched a major overhaul of the nation's financial regulatory system in 2010 by passing the Dodd-Frank Act. The law required the Internal Revenue Service to implement a host of measures, such as requirements that large banks retain more capital and boost transparency. According to a report by the Boston Consulting Group (BCG), federal financial oversight costs the U.S. economy about \$16.5 billion a year. To make up for the loss, Congress mandated the IRS to implement a temporary reduction in capital requirements, starting at an effective date of January 1, 2013, and ending in 2016. While the effectiveness of the tax holiday has been debated, it has generally been seen as a good thing. How the Money Is Raised According to the BCG report, the law will raise \$83 billion in revenue this year, and \$3.76 billion next year, so the government can cover the costs of the financial rules. It is estimated that the average investment firm has about \$2.7 billion in capital after taxes. The program essentially allows these firms to buy back 10% of their capital with the earnings it will generate from the tax break. The principle has been employed to raise funds for things like a U.S. response to the humanitarian crisis in Japan following the earthquake and tsunami in 2011, and to meet deficit reduction goals. The next phase is likely to be a 25 percent reduction in capital requirements for the first two years. The final phase will also enable the financial sector to pay a lower tax rate.
